



CHSBUA Scholarship Application

CHSBUA is encouraging participation in all training activities that aligns with our goals for umpire capabilities to improve.

The CHSBUA state program has about 20 scholarships available of \$175.00 each to be used by umpires in good standing (per the CHSBUA Constitution) throughout the state. The executive committee will accept all applications from the separate areas and award the scholarships based on the area director's recommendations.

Applications are available on our web site and will be submitted to their Area Director by April 1st with applications submitted to the executive committee for review during the 2Q BOD meeting. The executive committee will then consider each application and award the scholarships to the individual umpires.

The following is a time line for the application process:

1. Area Directors will remind members about the scholarship program at their local area meetings. A reminder should be shared at the master clinics.
2. Completed applications are emailed to the area directors by the April 1st cutoff date. Area directors are required to communicate this information to the executive board via 2Q BOD meeting.
3. During the 2Q BOD meeting, the executive board will review all applications and notify each selected umpire of their scholarship award no later than May 1st. Special situations and applications that may be received late will be considered on an individual basis. The executive board may make an additional appeal for more applications during the period between the April cutoff and the May notification dates.
4. Members will schedule themselves for the clinic of their choice and will provide a receipt of clinic participation to the member in charge of the selection process. Any other costs incurred by the umpire will be paid out of pocket. CHSBUA will not reimburse umpires for travel or lodging costs incurred as a result of the clinic attended. Any costs over the scholarship award value will be borne by the individual umpire. The clinic tuition up to \$175 is the only fee that CHSBUA will pay.
5. After attending the clinic, the umpire will provide a receipt of completion/participation from the clinic to the executive committee and area director for the reimbursement of \$175.
6. The Secretary/Treasurer will complete an annual report containing the names and clinics attended and the amounts of the scholarship awards and present the report to the executive board at its quarterly BOD meetings.
7. Each member that attends a clinic will be required to conduct a training session/overview at their designated area meeting with something that they learned at the clinic attended.
8. Members will not be eligible for additional re-imbusement from CHSBUA for 3 years.
